

Rehabilitation of Offenders Act 1974 Declaration Form

This form must be completed by all applicants.

The information disclosed on this form will not be kept with your application form during the application process. Failure to complete the declaration may render your application at ellenor invalid or for your offer of employment to be withdrawn for failure to disclose a declaration.

Statement on Recruiting Applicants with Criminal Records

ellenor recognise the contribution that ex-offenders can make as employees and volunteers and welcome applications from them. A person's criminal record will not, in itself, debar that person from being appointed to a post. Suitable applicants will not be refused posts because of offences which are not relevant to, and do not place them at or make them a risk in, the role for which they are applying.

Advice to applicants:

Prior to confirming an offer of employment, a designated senior manager will decide the relevance of the conviction in relation to the post being applied for.

A separate arrangement will be made with you to discuss the conviction in greater detail only if you have been successful at interview and if the conviction is potentially relevant to the post.

An offer of employment may be withheld or withdrawn on the basis of a criminal conviction where information has been knowingly withheld or where the nature of the offence is relevant to the post and would impact detrimentally on the charity, the applicant's ability to carry out the function of the role or would impact detrimentally for the care of patients, or employees.
